ORDER

In light of instructions contained in letter No. 7/56/2020/2H4/2789 dated 15.06.2021, issued by Additional Chief Secretary (Home) to Govt. of Punjab under section 2 of the Epidemic Diseases Act, 1897 and enabling provisions of the Disaster Management Act, 2005 the following restrictions are being imposed in the District with effect from 16.06.2021 till 25.06.2021 :-

1. a) Daily Night Curfew from 8 PM to 5 AM and Sunday curfew (from 8.00 PM on Saturday upto 5.00 AM on Monday) to be imposed throughout the District ; but all essential activities including those covered under Exemptions to continue to remain unaffected, unhindered and exempted from curfew restrictions.
- b) All Restaurants ( including in hotels), Cafes, Coffee Shops, fast food outlets, Dhabas etc., Cinemas, Gyms, museum to be opened at maximum 50% of capacity, subject to all their employees having received at least one dose of vaccination.
- c) Bars, Pubs and Ahatas to remain closed.
- d) All educational institutions i.e. schools and colleges to remain closed.
- e) No gathering of people more than 50 to be allowed, including for weddings/cremations.
- f) Non - AC Buses may operate to capacity but no standing allowed; AC buses to operate at maximum 50% of capacity.

2. Exemptions:- The following activities/establishments shall, subject however to observing Covid-19 appropriate behaviour by all concerned, remain exempted from Covid-19 restrictions above:

- I Hospitals, veterinary hospitals and all establishments, both in public and private sector, related to manufacture and supply of all medicines and medical equipment. Including the manufacturing & distribution units such as dispensaries, chemist & pharmacy (including Jan Aushadhi Kendras).
- II Laboratories, pharmaceutical research labs, clinics, nursing homes, ambulances etc. Transportation of all personnel of these establishments shall be allowed subject however to production of identity cards.
- III Shops dealing with supply of essential goods, milk, dairy and poultry products like bread, eggs, meat etc and vegetables, fruits etc.
- IV Shops/establishments selling industrial materials including raw materials, intermediaries as well as shops/establishments engaged in export and import activities.
- V Activities/establishments related to fisheries such as fish, meat and its products including supply of fish seeds.
- VI To and fro movement of passengers travelling by air, trains and buses on production of travel documents. Inter and intra state movement of all vehicles/persons carrying essential and non-essential goods.
- VII Delivery of all essential goods including food, pharmaceuticals, medical equipment etc. through E-Commerce.
- VIII Construction activities in both urban and rural areas.


- IX Agricultural including procurement, horticultural, animal husbandry and veterinary services.
- X Vaccinations out-reach camps.
- XI Activities of Manufacturing industry, Commercial & Private establishments and services given below including movement of all their employees/workers and vehicles carrying them upon production of requisite permission from their employers :
- Telecommunication, internet services, broadcasting and cable services, IT and IT enabled services.
  - Delivery of all essential goods including food, pharmaceuticals, medical equipment etc. through E-Commerce.
  - Petrol pumps and petroleum products, LPG, petroleum and gas retail and storage outlets, coal, firewood and other fuels.
  - Power generation, transmission and distribution units and services.
  - Cold storage and warehousing services.
  - Private security services.
  - Farming operations by farmers and farm workers in the field.
  - All Banking /RBI services, ATMs, Cash Vans and cash handling/ distribution services.

3. All shops including those in malls and multiplexes etc. may remain open till 6.00 PM. and restaurants/Hotels/dhabas etc. only for take away/home delivery allowed upto 9.00 pm.

There shall be strict implementation of all the extant directives of MHA/State Government on COVID-19 appropriate behaviour including social distancing norm of minimum 6 feet distance (2 Gaz Ki Doori), regulating crowds in market places and public transport and imposition of penalties prescribed for violation of COVID-19 appropriate behaviour like wearing of face masks and spitting in public places etc.

Any violation of these guidelines shall be punishable under Section 51 to 60 of Disaster Management Act, 2005 besides legal action under Section 188 of Indian Penal Code (IPC).




