ORDER


In light of instructions contained in letter no. 7/56/2020/2H4/3024, dated 09.07.2021, issued by Additional Chief Secretary (Home) to Govt. of Punjab, Department of Home Affairs & Justice, Chandigarh and in continuation of this office order No. 17934-17964/MA/MC-1, dated 15.06.2021, order Endst No. 19151-19185/MA/MC-1, dated 25.06.2021 & order Endst No. 19410-19443/MA/MC-1, dated 30.06.2021, the restrictions imposed vide these orders shall remain in force till Sunday, 11th July 2021.

1. From 12th July to 20th July 2021, only the following restrictions shall apply :
- No gatherings of more than 100 people indoors and 200 people outdoors shall be allowed.
 - All schools shall remain closed for students.
 - Colleges, coaching centres and all other institutions of higher learning shall be allowed to open, subject to a certificate having been submitted that all teaching, non-teaching staff and students have been given at least one dose of vaccination, at least 2 weeks ago.
 - All bars, cinema halls, restaurants, spas, swimming pools, coaching centres, sports complexes, gyms, malls, museums, zoos, etc. shall be allowed to operate subject to all staff and visitors over 18 years of age having taken at least one dose of vaccination. All users of swimming, sports and gym facilities shall be persons over 18 years, who have taken atleast one dose of the vaccine.

There shall be strict implementation of all the extant directives of MHA/State Government on COVID-19 appropriate behaviour including social distancing norm of minimum 6 feet distance (2 Gaz Ki Doori), regulating crowds in market places and public transport and imposition of penalties prescribed for violation of COVID-19 appropriate behaviour like wearing of face masks and spitting in public places etc.


Any violation of these guidelines shall be punishable under Section 51 to 60 of the Disaster Management Act, 2005, besides legal action under Section 188 of Indian Penal Code (IPC).
