ORDER

In light of instructions contained in letter no. 7/56/2020/2114/4012, dated 20.07.2021, issued by Additional Chief Secretary (Home) to Govt. of Punjab, Department of Home Affairs & Justice, Chandigarh to obtain and manage Covid-19, in exercise of the power conferred under section 2 of the Epidemic Disease Act, 1897, read with all other enabling provisions of Disaster Management Act, 2005, following restrictions are imposed till 31<sup>st</sup> July 2021:-

1. Gathering shall be restricted to not more than 150 persons indoors and 300 persons outdoors, subject to an upper limit of 50% of the capacity. Artists/musicians shall be allowed at such functions/celebrations in all areas with due COVID protocols.
2. All bars, cinema halls, restaurants, spas, swimming pools, coaching centres, sports complexes, gyms, malls, museums, zoos, etc shall be allowed to operate at 50% of their capacity, subject to all staff present being fully vaccinated. All users of swimming, sports and gym facilities shall be persons over 18 years, who have taken atleast one dose of the vaccine. Strict COVID protocols shall be put in place for operations.
3. Colleges, coaching centres and all other institutions of higher learning shall be allowed to open, subject to a certificate having been submitted that only fully vaccinated teaching, non-teaching staff and students shall be allowed.
4. Schools:
  - a) Schools for class 10,11 and 12 shall be permitted to open from Monday ( 26<sup>th</sup> July 2021) but only those teachers and staff shall be allowed to be physically present who are fully vaccinated. Physical presence of the students shall be purely at the consent of the parents and the option of virtual classes shall be continued. An undertaking to this effect shall be submitted to this office.
  - b) If the situation remains under control, the remaining classes shall similarly be allowed to open from 2<sup>nd</sup> August 2021.
  - c) Strict protocols shall be in place to ensure that COVID appropriate behavior is enforced. The District Education Officer shall issue instructions in this regard.

There shall be strict implementation of all the extant directives of MHA/State Government on COVID-19 appropriate behaviour including social distancing norm of minimum 6 feet distance (2 Gaz Ki Doori), regulating crowds in market places and public transport and imposition of penalties

prescribed for violation of COVID-19 appropriate behaviour like wearing of face masks and spitting in public places etc.
