



A meeting is scheduled under the chairmanship of Principal Secretary, Social Security Women and Child Development on 10.09.2021 at 12:00 noon through video conferencing.

Kindly refer to this office letter no. PS/PSSWCD/2021/ 426 dated 5.05.2021, SARA/ICPS/2021/23449-56 dated 01.07.2021 and SARA/ICPS/2021/spl-1 dated 30.06.2021 on the subject cited above.

Kindly see below the data related to children who have lost both their parents and the families that have lost their breadwinner in the COVID -19 pandemic:-

The following agenda items will be discussed during the meeting:-

Agenda No: 1 Department of School Education

- 1) As per the Notification by Hon'ble CM Office, free education to children who became orphan and lost one parent due to COVID shall be provided. The Nodal Department has identified 10 orphans and 543 single parent children enrolled in Government Schools. Kindly provide the latest status of the beneficiaries and status of pending cases.
- 2) As per directions of Hon'ble Supreme Court, in SMW4 2020 titled as Re: Contagion of COVID-19 Virus in Children Homes, it was informed vide letter No. AD(CO)/SSE/2021/2021234716/218 dated 09.07.2021 that an amendment in the provisions of the Fee Regulation Act inter-alia providing that in case a child loses father/mother who is a bread earner in the family, no private school shall charge any fee from such students till the completion of the education in that school. Information of only 03 children from Districts Hoshiarpur and Fatehgarh Sahib has been received. However, status of free education 504 children (24 orphan and 480 single parent children) who are enrolled in Private Schools is not clear. Further, compliance of the same has also been sought by Hon'ble Supreme Court in SMW4 of 2020. (District wise list attached at Annexure A)

Agenda No: 2 Department of Higher Education/ Technical Education

- 1) As per the Notification dated 15.07.2021 received from your department free education up to graduation who became orphan and lost one parent due to COVID shall be provided. The Nodal Department has identified 4 orphan and 29 single parent children studying at graduate level in Government Institutions who have been covered under free education. Kindly provide the latest status of beneficiaries and Status of pending cases.
- 2) As per SMW4 2020 titled as Re: Contagion of COVID-19 Virus in Children Homes the Nodal Department has also identified 03 orphan and 22 single parent children studying at graduate level in Private Institutions who have been covered under free education. Kindly provide the latest status.

Agenda No: 3 Department of Health and Family Welfare Department.

- 1) 01 Death Certificate of the deceased where children became orphan was not issued in District Sangrur and the child did not receive the benefits. Similarly 06 other death certificates where children lost one of their parents were not issued and children of such families did not receive the benefits. (District wise list attached at Annexure B)
- 2) Out of 1229, only 194 beneficiaries have been covered under Sarbat Sehat Bima Yojna. Please provide the current status of the remaining beneficiaries and reason for delay.

Agenda No: 3 Department of Social Justice and Empowerment.

- 1) Out of 1229 children, 478 are girls and only 70 girls have been registered under Aashirwaad Scheme. As per the reports received from the districts by the Nodal Department, the benefit cannot be allocated to the children whose family income is more than Rs.32,790 per annum, as per your policy. Kindly review the policy in regard to COVID affected children and provide the status of pending cases.
- 2) Steps taken for providing benefits of the said scheme to girls who are nearing marriageable age or are minors but may be covered under the Scheme for availing benefits at the time of their marriage in future. Also, provide information about the records of such beneficiaries being maintained by your Department for future reference.

Agenda No: 4 Department of Food and Civil Supplies

- 1) Smart Ration Cards to only 330 children have been issued. The details of the beneficiaries have already been shared with your office vide this office letter No. ICPS/2021/30614 dated 26.07.2021. However, no update has been received in this regard. Also, apprise the reasons for delay.

Agenda No: 5 Department of Employment Generation.

- 1) Only 63 children have been registered under Ghar Ghar Rozgar Te Karobar Yojna.
- 2) The district units have also reported that children who are studying in any class below 10th will not be registered under this programme of your Department. (Report placed at Annexure A & B)
- 3) Children who are studying below class 10 should be covered under the given programme. Register such children for future benefits.
- 4) Also, inform about the monitoring mechanism of your Department for keeping record of such cases for future reference.

Agenda No: 6 District Level COVID Relief Committee

- 1) Deputy Commissioners were designated as Nodal Officers for management and providing relief to such cases as per this office letter No. SARA/ICPS/2021/spl-1 dated 30.06.2021. You were also requested to conduct fortnightly meeting to review such cases and expedite the process. Therefore, you are requested to update how many meetings have been taken till date.
- 2) What steps have been taken to provide the benefits to these children and families? It has been observed that there is a difference in the beneficiaries identified and benefits provided. Approximately 200 beneficiaries have not received pension benefits yet.
- 3) In SMW4 2020 titled as Re: Contagion of COVID-19 Virus in Children Homes, the information of such children should be updated on Bal Swaraj Portal. However, the uploading of information of 257 children is pending on Bal Swaraj Portal.
- 4) The registration of children on PM CARES portal is only completed after the recommendation from the District Magistrate. However as per the dashboard of the Portal

only 4 cases have been recommended by the DMs out of 37 registered cases (Annexure D). The instructions of the Ministry along with Login id and Passwords were shared with you vide this office letter no. ICPS/2021/30793-814 dated 27.07.2021

5) Kindly provide the information about difficulties being faced at interdepartmental level.

Therefore, a review meeting under the chairmanship of Principal Secretary, Social Security Women and Child Development is scheduled on 10.09.2021 at 12:00 noon through video conferencing. You are requested to attend the meeting with full details.

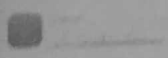

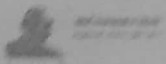
