
It may also be noted that getting an award and 5 star ranking is not the only objective of Swachh Vidyalaya Puraskar, rather the key objective is to have sustainable, child friendly, gender and divyang appropriate, climate resilient water, sanitation, hand washing facilities in schools besides adherence to hygienic as well as COVID appropriate behaviour in schools once they re-open.

SVP based situational analysis is instrumental in identifying infrastructural and service level gaps for development of school level Swachhata Action Plan (SAP), as envisaged under Samagra Shiksha. The Swachhata Action Plan can be effectively utilized by schools, to mobilize resources and transform WASH infrastructure through active support of key stakeholders like rural/ urban local bodies, CSR, local donors and influential/ resourceful community members. Through SAP, thousands of schools have demonstrated local innovative approaches to develop and sustain improved WASH services along with COVID sensitive infrastructure and behaviour.

In view of the above, it is requested to ensure maximum (100%) participation of schools in the SVP 2021-22 including government, government aided and private schools belonging to all school managements. The last date of application for schools is 31st March 2022. In order to ensure maximum participation in SVP 2021-22, you may use appropriate local platforms over social media or events for wider reach in the local language besides engaging local celebrities, sportspersons and influential leaders.







Further, please let us know if you have the need to organize any technical SVP self- registration related trainings of education department officials, master trainers and teachers so that UNICEF can be asked to provide the necessary support in a timely manner. In case of the states of Andhra Pradesh, Assam, Bihar, Chhattisgarh, MP, Rajasthan, Odisha, Jharkhand, Maharashtra, Gujarat, Tamil Nadu, Karnataka and Telangana and West Bengal you may also contact local UNICEF field office to provide the essential training support.

It is also requested to ensure formation of SVP verification and selection committees at State and district level in a timely manner so that once nominations are received, the verification can be completed on time. The members of these verification and selection at the State/UT and district level may be sensitized for taking up pro- active role. Please ensure that the SVP self-registration, verification process and related meetings all the COVID appropriate behaviours are strictly followed.

Like SVP 2017-18, State/UT and District level dashboards have been developed to help in review of participation of schools, selection of schools for district and State/UT level awards, management and coordination.
