ORDER

In the light of instructions contained in letter no.7/56/2020/2H4/ 4759-61 Dated 13.08.2022 issued by Principal Secretary (Home) to Govt. of Punjab, Department of Home Affairs & Justice, Chandigarh, the number of positive cases, positivity rate and hospitalization are showing an upward trend.

Therefore, in exercise of the powers conferred under section 2 of the Epidemic Disease Act, 1897, read with all other enabling provisions of the Disaster Management Act, 2005, and in supersession of all previous instructions on the subject, following instructions are being issued with immediate effect :-

1. That wearing of appropriate masks shall be ensured in all Educational Institutions, Government and Private Offices and indoor/ outdoor gathering, malls, Public places etc. for the prevention of further spread of the virus in the population and for the well- being of every individuals.
2. COVID-19 appropriate behavior to be strictly followed like social distancing, respiratory etiquettes and no spitting at public places.
3. Anyone having symptoms of COVID-19 must get tested and follow COVID-19 protocol.
4. All hospital/ Labs/Collection Centers offering testing for COVID-19 must upload details of tests including positive and negative results on COVA Portal of Government of Punjab as well as intimate complete testing details to respective district and State COVID-19 Cell.
5. Those due for second dose and precartionary dose of COVID-19 vaccine must take it at the earliest.
