You may be aware that the Department of Social Justice & Empowerment is implementing an umbrella scheme namely 'PM Young Achievers' Scholarship Award Scheme for a vibrant India (PM-YASASVI) for the welfare of OBC, EBC and DNT students. One of the component of this scheme is Top Class School Education for OBC, EBC and DNT students.

2. In brief, under the Top Class School Scheme, we have shortlisted some reputed schools based on passing percentage in Xth and XIIth Exams. Under the scheme, the Central Government will provide Scholarship of Rs.75,000/- p.a for Class 9 and 10 and Rs.1,25,000 p.a. for Class 11 and 12 covering the School fee, hostel fee etc. The selection of students will be done through merit in the YASASVI Entrance Test (YET) being conducted by National Testing Agency on 11.09.2022. Scheme guidelines and advertisement are available on the website of the Ministry i.e. <https://socialjustice.gov.in - schemes>.

3. During the year 2022-23, the Department is to provide assistance to 15,000 students. Application for registration of the test are open now from 27.07.2022 to 26.08.2022 through the web portal <https://yet.nta.ac.in>. A list of schools selected from your State/UT along with a copy of the advertisement are attached for your kind reference.

4. As this a very good opportunity to encourage meritorious students from these communities, I request you personally to look into the matter and give wide publicity of YASASVI Entrance Test in the shortlisted schools so that large number of students may appear in the examination.

- **Applications open from:** 27.07.2022 to 26.08.2022
- **Correction window:** 27.08.2022 to 31.08.2022
- **Display of Admit cards:** 05.09.2022
- **Date of the exam:** 11.09.2022 (Sunday)
- **Documents for application:** Student should have a valid functional Mobile Number, Aadhar Number (UID), Aadhar linked Bank Account, Income Certificate and Caste Certificate.
