Dear Sir/Madam,

We enclose a copy of the scheme for National Bravery Award- 2023 received from Indian Council for Child Welfare alongwith a nomination form on the subject cited above.

We shall be grateful if you forward nominations of eligible children between 6 to 18 years of age to this Council at the earliest, so that the Punjab children do not go unnoticed for the National Bravery Award. The cases of saving children from drowning and from beastly attack by wild animals are symbols of bravery but there must be many more instances, where the particular act of bravery of a child is distinctly visible. It should be an act of spontaneous selfless service in the face of risk to life. threat of physical injury and or an act of courage and daring against a social evil/crime. So, wide publicity about the National Bravery Awards be given through the Local News Papers & TV channels. The nominations must reach this office latest by 5th October, 2023, in respect of incidents having occurred between 1st July, 2022 to 30th September, 2023. Each application must be accompanied with on the spot verification of the case.

Incomplete applications or those not sent in the prescribed format will be rejected. Please ensure that all supporting documents are duly authenticated by the listed competent authorities and that all documents in the local/regional language are accompanied with translations in Hindi/English. Newspaper clippings/Magazine clippings must be attached with the application form.

INTRODUCTION:

The Scheme of National Awards to Children for bravery was started 66 years ago in the year 1957; at was in this year that the Scheme of mind and sources Since year that two children a boy and a girl were first rewarded for their exemplary presence of mind and courage. Since then, ICCW confers National Awards to children, every year.

OBJECTIVES

The main objective of the scheme is to give due recognition to the children who perform acts of b to inspire other children to follow their example. The deed should be "an act of spontaneous self face of risk to life or threat of physical injury and or an act of courage and daring against a social exili

PROCESS OF INVITING APPLICATIONS

Wide publicity is given for the programme. Nominations are invited from all over India

PROCESS OF APPLYING

Nominations are received in the prescribed application form which can be obtained from ICCW head or can be downloaded from ICCW's website. The application should be recommended to wood; this listed Competent Authorities. The form is to be accompanied by a write-up of about 250 words give the deed performed by the applicant, proof of date of birth, Newspaper/Magazine Clippings and F ing the details of Report (FIR) or Police Diary filed with the Police Station. The account of the incident as documents should preferably be endorsed by two of the listed Competent Authorities.

AGE LIMIT

The child should not be below 6 years and above 18 years of age on the date of the incident.

RECOMMENDING/COMPETENT AUTHORITIES

The application must be recommended by any two of the following:

- Principal/Headmaster of the School in which the applicant is studying or Head of Pancha
- 2. President/ General Secretary of the State Council for Child Welfare.
- 3. Collector/DM/Govt. Official of equivalent rank
- Supdt. Of Police of the area or Police official of higher rank.

DATE OF INCIDENT
