Dear Sir/Madam,

We enclose a copy of the scheme for National Bravery Award- 2023 received from Indian Council for Child Welfare alongwith a nomination form on the subject cited above.

We shall be grateful if you forward nominations of eligible children between 6 to 18 years of age to this Council at the earliest, so that the Punjab children do not go unnoticed for the National Bravery Award. The cases of saving children from drowning and from beastly attack by wild animals are symbols of bravery but there must be many more instances, where the particular act of bravery of a child is distinctly visible. It should be an act of spontaneous selfless service in the face of risk to life, threat of physical injury and or an act of courage and daring against a social evil/crime. So, wide publicity about the National Bravery Awards be given through the Local News Papers & TV channels. The nominations must reach this office latest by 5<sup>th</sup> October, 2023, in respect of incidents having occurred between 1<sup>st</sup> July, 2022 to 30<sup>th</sup> September, 2023. Each application must be accompanied with on the spot verification of the case.

Incomplete applications or those not sent in the prescribed format will be rejected. Please ensure that all supporting documents are duly authenticated by the listed competent authorities and that all documents in the local/regional language are accompanied with translations in Hindi/English. Newspaper clippings/Magazine clippings must be attached with the application form.

**SCHEME OF ICCW NATIONAL BRAVERY AWARDS FOR CHILDREN (2023)**

**INTRODUCTION :**

The Scheme of National Awards to Children for bravery was started 66 years ago in the year 1957. It was in this year that two children a boy and a girl were first rewarded for their exemplary presence of mind and courage. Since then, ICCW confers National Awards to children, every year.

**OBJECTIVES**

The main objective of the scheme is to give due recognition to the children who perform acts of bravery with a view to inspire other children to follow their example. The deed should be "an act of spontaneous selfless service in the face of risk to life or threat of physical injury and or an act of courage and daring against a social evil/crime".

**PROCESS OF INVITING APPLICATIONS**

Wide publicity is given for the programme. Nominations are invited from all over India

**PROCESS OF APPLYING**

Nominations are received in the prescribed application form which can be obtained from ICCW headquarters office or can be downloaded from ICCW's website. The application should be recommended by two of the listed Competent Authorities. The form is to be accompanied by a write-up of about 250 words giving the details of the deed performed by the applicant, proof of date of birth, Newspaper/Magazine Clippings and First Information Report (FIR) or Police Diary filed with the Police Station. The account of the incident as well as supporting documents should preferably be endorsed by two of the listed Competent Authorities.

**AGE LIMIT**

The child should not be below 6 years and above 18 years of age on the date of the incident.

**RECOMMENDING/COMPETENT AUTHORITIES**

The application must be recommended by any two of the following :

1. Principal/Headmaster of the School in which the applicant is studying or Head of Panchayat/Zila Parishad.
2. President/ General Secretary of the State Council for Child Welfare.
3. Collector/DM/Govt. Official of equivalent rank.
4. Supdt. Of Police of the area or Police official of higher rank.

**DATE OF INCIDENT**

Incidents which have occurred between July 1, 2022 to September 30, 2023 will be considered for the 2023 awards. The Selection Committee, may at its discretion, relax the date by a maximum period of six months prior to July 2022 if it so deems fit. ICCW reserves the right to relax the date of the deed for a very deserving act for recognition.

**DATE OF SUBMISSION OF APPLICATION**

Last date of submission of application is, October 05, 2023.

**SELECTION PROCEDURES**

The selection is made by a high powered Committee constituted by ICCW.

Applications once rejected for whatever reason will not be entertained again.

The Selection Committee may at its discretion consider relaxation of any of the conditions/rules if it so deems fit.

**Submission of application does not guarantee selection.**

The decision of the Selection Committee shall be final.

**AWARD**

The Award confers;

- A Medal (Gold, Silver)
- A certificate
- Cash award.

The Awardees also receive various gifts from Philanthropic Organisations. The Award will be presented at New Delhi by an eminent and distinguished personality. The Awards details are given below :

In other cases pertaining to rescue from fall, the height of the structure must be mentioned.
