Sir/Madam,

As you must be aware that Holi Mela at Mairi, Sub Division Amb, District Una, Himachal Pradesh will be commencing w.e.f. 21-03-2021 and continue until 31-03-2021. A large number of devotees pay their obeisance at Dera Baba Badbhag Singh ji, Gurudwara Manji Sahib and other shrines at Mairi from the State of Punjab and Haryana. Many of these pilgrims stay at Mairi for entire duration of the Mela.

Such large gathering of people is likely to cause spread of deadly Covid-19 in local population. In view of this to contain the resurgence of Covid-19, the District administration has taken a decision that the pilgrims visiting the above holy religious places come with Covid-19 "Negative" report issued during the period of maximum 72 hours before their arrival in Una.

Therefore, your cooperation is solicited to apprise through wide publicity the general public of your respective districts desirous of visiting above holy religious places to travel with the Covid-19 "Negative" report from Government certified labs only which should be issued within 72 hours prior to arrival in Una. Any person not having the desired Covid-19 Negative report should be advised not to travel to Mairi for Holi Mela-2021. Please make it

convenient to make all arrangements to convey/apprise by all means of mass communications of above measures so that no inconvenience is caused to devotees visiting to this religious place. It is further requested that steps taken for this purpose may please be conveyed this office through email (dc-una-hp@nic.in) please.
